
# Chairman of the Board of Directors

Coached by Conservatory Artist-Teacher Andrew Cook, students Geneva Lewis (13), violin; Ben Penzner (15), viola; Alex Mansour (14), cello; and Katelyn Vahala (15), piano; joined the Mozarteum Concert Tour April 7 to 15. Included in their schedule were three morning practice sessions, two master classes, a dress rehearsal, and a final concert.

When they were not making music, the quartet visited the Triebenbach Castle where the Mozart family vacationed, the Herrenchiemsee Palace, and the Bad Reichenhall lake district. Highlights of their trip included master classes at the Mozarteum, an evening concert at the Unser Burgerbrau restaurant, a tour of the Mozarteum, and a dress rehearsal in the Wiener Saal. Upon their return, the ensemble won first prize at the 2013 VOCE statewide competition for interme-


#### 2011-2012 Operating Income



TOTAL INCOME \$2,030,038




#### 2011-2012 Operating Expenses




#### Student Profile: Residence

# **OUTREACH**

The Pasadena Conservatory of Music believes that every child deserves the opportunity to discover his or her capacity for music-making, and devotes approximately ten percent of its annual operating budget to its outreach programs. Every year PCM provides ongoing tuition–free instruction for children in public schools and financial aid and scholarships for deserving young musicians to study at the Conservatory. This past year the Conservatory's outreach program served over 3,200 students in the Pasadena Unified School District and other San Gabriel Valley school districts.

Although my family faced financial hardship over the years, the Conservatory gave me the chance to fall in love with the piano, and on a broader scale, music. Without your help, I would not be playing the piano."

#### Young Musicians at Jefferson Elementary

During the 20II-20I2 school year, all 630 preschool through fifth grade students at Jefferson Elementary received 32 weeks of music education from Conservatory teachers employing the curriculum of the Conservatory's Young Musicians program. Students in YM at Jefferson learn the fundamentals of music, including melody, rhythm, tempo, dynamics, and expression.


#### Guitar for All

Low-income students enrolled in San Gabriel Valley schools at the upper elementary and middle school level are selected to receive weekly tuition-free guitar lessons with Conservatory teachers.

#### Music Mobile

Assemblies conducted by Conservatory teachers introduce third grade students throughout the San Gabriel Valley to the concepts of classical music and to the four families of instruments that comprise an orchestra. This program serves more than 2,500 students annually and is sponsored by the Pasadena Showcase House for the Arts.



# The Conservatory LEGACY SOCIETY



"I think PCM is an organization that Pasadena needs. It makes a difference. I love my weekly piano lessons and want to help make sure the Conservatory can serve our community well into the future."

Legacy Society member **Dr. Ralph F. Miles, Jr.** had a long career with the Jet Propulsion Laboratory, where he was involved in the first exploratory missions to Mars. Later he was involved in flights to Jupiter, Saturn, Uranus, and Neptune. Now retired, he enjoys hiking mountains and studying piano with Elizabeth Babor.

Ralph had his first piano lesson when he was six years old. Although he didn't become a dedicated pianist at the time, music became an important part of his life and he still has fond memories of marching in the Rose Parade as a clarinetist in the band from John Marshall Junior High School.

Ralph's career at JPL spanned twenty-nine years. After retiring he decided to simplify his life and only engage in activities that bring him pleasure. "Playing the piano brings me enjoyment," he said. "I play about an hour each day. It's necessary to have a teacher if you want to improve; otherwise, you keep making the same mistakes." Bach, Beethoven, Chopin, and Satie are composers he listens to and plays.



"My grandmother introduced me to classical music when the Metropolitan Opera started its weekly radio broadcasts. Saturday afternoons were a special time spent sewing by the radio, and listening to great voices and great music. Music opened a whole world of feeling and experience for me that nothing else satisfied. I want children now and in the future to enjoy that world, and to know its consolation and inspiration over a lifetime, as I have.

One of the many things I value about PCM is that students of any age play musically. It's about so much more than the notes, and somehow PCM students understand and communicate that invisible web of beauty, feeling, and order that is music, no matter their age. PCM is a community of music lovers, as well as an institution that has planted strong and vital roots in Pasadena, and deserves to continue. I love being a part of its past and present, and want to be a part of its future, too. I only wish I could add a few more zeroes to my bequest!"

During her six years on the board, **Peggy Spear** brought her considerable experience in fund development to bear. As the former Major Gifts and Grants Director at the Huntington Library, Art Collection, and Botanical

Gardens, she has been an invaluable source of know-how and wisdom. Her tenure as chair of PCM's Development Committee was a period of building and growth.
