If you are awarded financial aid from PCM for the 2020-2021 school year, you will receive a contract that indicates your co-payment for each quarter. **Please sign and return this contract by Friday, August 14, 2020 with your fall co-payment and registration fee of \$50. Failure to return contracts and co-payments by the due date may result in withdrawal of the award.**
